- The return of the Fund will be compared with the return on an index which will initially be the MSCI North America Index (with net dividends), the Fund's benchmark index.

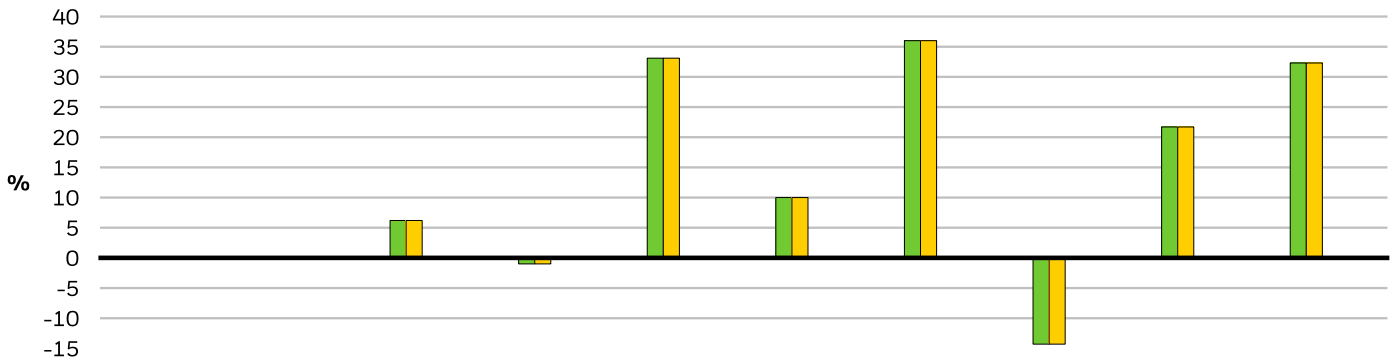

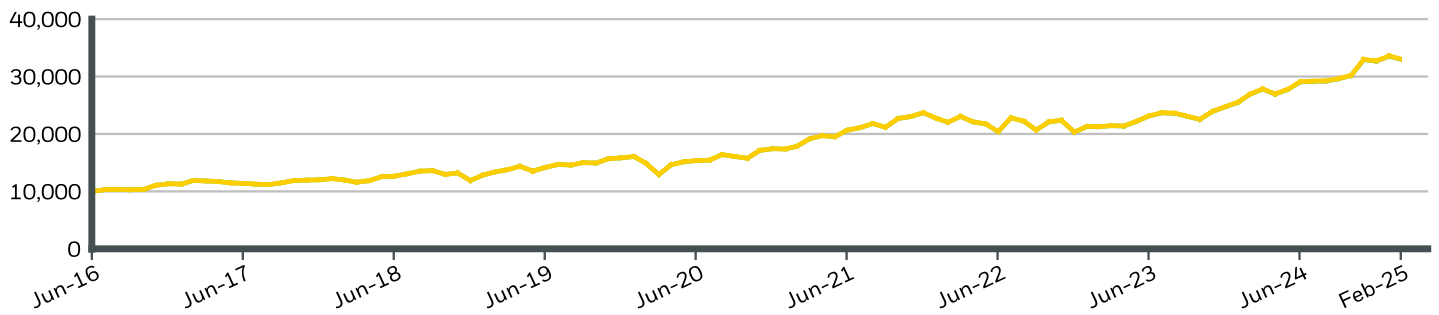

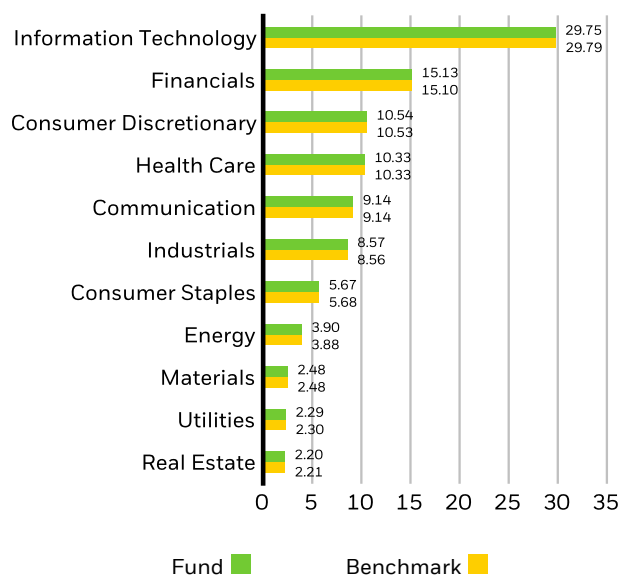
