What is this Product?

The Fund is a sub fund of Brooks Macdonald International Multi Strategy Fund Limited, a non UCITS open ended investment company. There is no fixed term or maturity date. It is classified as a fund of funds which is a fund that invests in a number of other funds. Fund launch date: 11/08/2021.

Objective and Policy

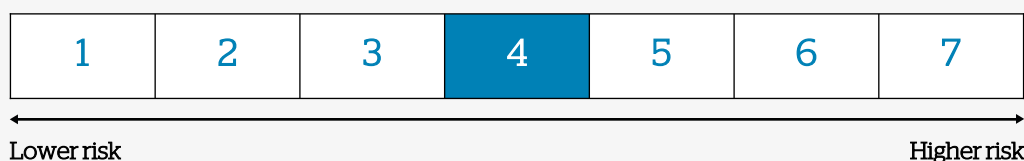
The objective is to seek to provide capital growth through exposure to a range of funds weighted towards growth asset classes, whilst maintaining balanced weighting to fixed interest securities.

The policy is to invest in collective investment funds and multimanager funds managed by a range of fund managers including, but not limited to, Brooks Macdonald International Fund Managers Limited and other subsidiaries of Brooks Macdonald Group plc ("Brooks Macdonald Group" or "Group"). These funds, in turn, invest in a number of asset classes. These could include, but are not limited to bonds, equities, properties and cash.

This Fund may be suitable for you if you are willing to risk a loss to your capital and are looking for a medium to long term investment. The Fund can be terminated without the agreement of shareholders, if the value of the Fund is less than £5,000,000 or currency equivalent for a period of four consecutive weeks. Shareholders will be given at least three weeks' written notice of any such action.

What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk and volatility of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or the type of underlying assets in which the Fund invests.



The risk indicator assumes you keep the product for a minimum of five years.

The actual risk can vary significantly if you sell your shares at an early stage and you may get back less.

We have classified this product as 4, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the amount you could get back.

The base currency of the Fund is sterling. It can invest in securities denominated in currencies other than sterling so can be affected by currency fluctuations which may affect the return. The return from investing in a fund denominated in a currency other than the currency of your residence or domicile may be affected by currency fluctuations. Dividends, which will be automatically reinvested in shares of the Fund, are not guaranteed and the amount you receive may fluctuate.

This table shows the money you could get back over the next 5 years, under different scenarios, assuming that you invest £10,000. The scenarios shown illustrate how your investment could perform. What happens if Brooks Macdonald International Fund Managers Limited is unable to pay out?

The maximum compensation payable to any one investor is £48,000 and is dependent upon the size of the investment. The total amount of compensation in any one year is limited to £5,000,000. What are the costs?
